- *Felony calendars and all law and motion shall be set Tuesday-Friday. Any request for a Monday setting requires judicial approval.*
- *Felony/Misdemeanor Sentencings shall be scheduled in the designated court by the Judicial Officer who accepted the plea, unless held in a non-criminal court. Arbuckle enters and set appropriately.*
- *All Felony matters shall be scheduled at 8:30 am on the Felony Calendar and assigned by the Court, Tuesday-Friday.*
- *All misdemeanors shall be set at 9:15 am on the misdemeanor calendar and assigned by the Court.*
- *Criminal calendars will be assigned to a court location by Court staff. Please review online calendars for court locations.*
- *Any request for Criminal Judicial Intervention shall be set two days from the date of the request at 4:00 pm, see Local Rule 3.8.*
- *Settlement Conferences for civil cases will be set at the request of counsel, see Local Rule 2.5. on Tuesday at 3:00 pm.*
- *Ex Parte Hearings in civil and family law are scheduled at 1:15 pm the following day if submitted by 12:00 pm or within 2 days if submitted after 12:00 pm.*
- *Appellate Calendars are called on the first Friday of odd months. Please review Appellate Bench Memo posted under the calendar plan for specific dates.*
- *Drug Court, Domestic Violence (DV) Calendars are called bi-weekly. Please review Drug Court and DV Review memos posted for specific dates.*
- *Mental Health Diversion Review Calendars will be called weekly on Monday afternoons. Mental Health Diversion Hearings will be scheduled weekly by the courtroom clerk at 2:30 on Monday afternoons.*
