**SETTING EMERGENCY STATE WIDE BAIL; MULTIPLE HOLDS;
ORDERS OF RELEASE; EFFECTS ON CREDIT CALCULATION**

A defendant held in custody on multiple cases or a defendant with multiple custodial holds may have qualifying cases set at the amount of zero-dollar bail pursuant to California Rules of Court, Emergency Rule 4. If the setting of zero cash bail results in the defendant being detained on some holds and released on the balance, the Court will preserve the issue of equitably awarding custodial credit in all cases and counsel may argue that issue at the time of sentencing.
